



# **ACCP Communities Policy**

### **Overview**

ACCP Communities is a members-only benefit that provides access to your fellow members, ACCP staff, and a library of CSR resources. To ensure the best possible experience for all participants, we have established the ACCP Communities Policy for participation.

#### **ACCP Commitment**

At ACCP, we foster and uphold a culture of dialogue and respect for all ideas. We take deliberate actions to ensure there are no barriers to full participation and equal opportunity for all and without bias on the basis of gender, gender identity/expression, ethnicity, race, native or indigenous origin, age, generation, sexual orientation, culture, religion, belief system, marital or family status, socioeconomic status, language, accent, physical ability, mental health, educational level or background, geography, nationality, work style, thinking style, personality type, physical appearance, and/or any other characteristic that can be identified as recognizing or illustrating diversity. We expect, without exception, that all who work for, volunteer with, or participate with ACCP treat one another with dignity and respect at all times in our workplace, at our functions, sponsored activities and/or in all ACCP-related interactions. ACCP is committed to providing a safe and welcoming environment in all association activities, including online activities. We do not tolerate discrimination, intolerance, harassment, aggression, solicitation, or unacceptable behavior of any kind at ACCP, whether in person or virtually.

## **Engaging on ACCP Communities**

ACCP Communities is an online community exclusively for the use of ACCP members to engage in discussion, seek resources, learn best practices, and receive feedback from your peers and staff on issues in corporate citizenship. ACCP encourages members to share questions with one another, successes, challenges, constructive feedback, and perspectives on topics related to CSR, ESG, DEI, disaster relief, and other issues for which a peer exchange would be helpful.

- To post in ACCP Communities, members must first log-in to their ACCP account at ACCP.org, then select "Communities" from the "Member Resources" tab. Once the ACCP Communities page opens, members can click the arrow next to "Participate" in the top menu, then select "Post a Message."
- State concisely, clearly and accurately the topic of your comments in the subject line. This allows members to respond most appropriately to your posting and makes it easy to search the archives by subject.
- Send substantive questions and content related answers to the full group by using the "Reply" function so other members can learn from your contributions.
- Send messages such as "thanks for the information" or "me, too" to individuals, not to the entire list. You can do this by using the "Reply Privately" link in every message. You can also use this function when you do not want your response to be seen by the entire group.
- Please do not send administrative messages, such as "remove me from the list," to the group. Instead, you may use the web interface to change your settings or to remove yourself from a list. If you are changing email addresses, you do not need to remove yourself from the list and rejoin under your new email address. Simply change your settings. If you need help with your settings, contact the <u>ACCP Membership Team</u>.

## **Etiquette and Rules of Conduct**

To maintain fruitful and respectful discourse in ACCP Communities, ACCP reserves the right to suspend, remove content, or terminate participation for members who violate these rules. Please view <u>ACCP Policies</u> for a list of policies that guide our work, including the <u>Member</u> <u>Eligibility and Conduct Policy</u>.

- **Respect.** Focus on the content of posts and not on the people making them. Please extend the benefit of the doubt to newer guests and members; there's no such thing as a stupid question.
- **Don't attack others**. The discussions in the online community are meant to stimulate conversation not to create contention.
- **No solicitation.** ACCP Members are expected to participate in ACCP Communities in their roles as stewards of their company's corporate citizenship efforts. You may not use ACCP Communities to promote your or your company's business, practice, products, or services. ACCP reserves the right to remove such messages and potentially ban sources of solicitation.
  - Resources that are free to all and share learnings and opportunities to further education and understanding of the CSR field are permitted to be shared in ACCP Communities.
- Use caution when discussing products, vendors, or partners. Information posted on any platform is available for all to see, and comments may be subject to libel, slander, and antitrust laws. If you've found a product or service helpful, please share your experience with the group in a respectful way.
- All defamatory, abusive, profane, threatening, offensive, or illegal materials are strictly prohibited and will be removed and may subject the person posting the same to be suspended or terminated from participation in the ACCP Communities.
- Do not post anything that you would not want the world to see or that you would not want anyone to know came from you. While ACCP Communities are strictly members-only, ACCP is not liable for the spread of information through downloads, screenshots, etc.
- Out of respect for privacy, participants may not copy or take screen shots of posts in ACCP Communities to be shared in your companies or externally.
- Remember that ACCP and other participants could reproduce postings. Some general tips to help you maintain good etiquette when reproducing content:
  - When posting items in our collaborative environment, please indicate if the item is not available for reuse.
  - Be courteous. Please ask participants for permission to republish their words elsewhere (especially if elsewhere would be a publicly viewable setting).
  - Internally, when citing ACCP Communities discussions, please include a link back to the original discussion.
  - Post content that you have personally created or have permission to use and have properly attributed to the content creator.

If any inappropriate posting is <u>brought to ACCP's attention</u>, ACCP will take all appropriate action. ACCP reserves the right to terminate access to any users who do not abide by <u>ACCP</u> <u>Policies</u>. When unsure whether content is consistent with these policies, please err on the side of caution and do not post the content in ACCP Communities. If there are any questions on what content is appropriate to post, please contact the <u>ACCP Membership Team</u>.

## Reporting a Policy Violation

If you feel you are being harassed, solicited, notice that someone else is being treated poorly by an ACCP member or ACCP staff, or feel that a post violates the ACCP Communities Policy, please immediately contact any member of the <u>ACCP team</u> who will escalate your concern to the appropriate parties.

Additionally, if you are unsure who to contact, you may contact the <u>ACCP Membership Team</u> to report incidents at any time so that we can take the appropriate action. Please include the post title, link to the post, or the name of the person violating the policy. Please reference our <u>Whistleblower Policy</u> for additional contact and reporting information.

#### **Consequences of Unacceptable Behavior**

ACCP reserves the right to take any action deemed necessary and appropriate, including immediate removal of the post/comment, removal of the member from ACCP Communities, or removal of access to ACCP Member Benefits in response to any incident of unacceptable behavior. ACCP reserves the right to terminate access to any users who do not abide by <u>ACCP Policies</u>.
