Virtual Summits

\$10,000/Summit (non-exclusive)

In 2026, ACCP will host three Virtual Summits on the topics of Aligning CSR Strategy With The Business, Ambassador Programs, and Corporate Grantmaking. Virtual Summits are 1-2 day virtual programs that provide a deep dive into priority CSR topics.

Forum – A CSR Intensive

\$15,000 (non-exclusive) | Chicago, IL
April 20 – 23, 2026

ACCP's Forum – CSR Intensive, designed for early career CSR professionals, provides foundational knowledge of the full spectrum of corporate social impact programs. Participants gain practical skills and a peer network that will kickstart their career in corporate social impact. Cohort limited to 40 participants.

RISE: Realizing Inclusive Leadership in CSR

\$10,000 - \$100,000

*RISE is ACCP's mid-career leadership development program designed to build a pipeline of inclusive CSR leaders. This is an 8-month cohort experience that combines in-person learning, network building, virtual sessions, and mentorship with a CSR Leader. Cohort size limited to 20 individuals**

Sampling of benefits dependent of level of support:

Local Community Events


\$5,000 per event*
