## Who We Are

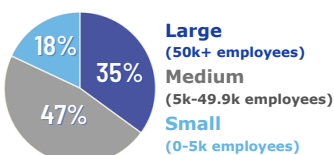

## What We Do

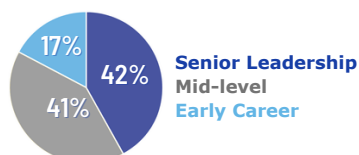
